MEMBERSHIP TERMS & CONDITIONS

- Memberships are non-transferable and non-refundable. Olympic View Golf Club reserves the right to change rates without prior notice.
- A member who suffers an injury that prevents him/her from playing golf for a minimum of 3 months may be eligible to apply for a medical leave request.
- Temporary suspensions for medical purposes will be reviewed and considered on an individual basis. A medical note must be submitted along with your medical leave application. There will be a \$100 administrative fee for approved medical suspensions.
- The Clubhouse and/or Golf Course may be closed to accommodate private and large functions – advance notice will be given.
- Olympic View Golf Club assumes no responsibility for any individual property damage or bodily injuries incurred while at the Club
- No outside alcohol is allowed in the Clubhouse or on the Golf Course.
- Any behavior deemed inappropriate toward a team member or fellow member will not be tolerated. All Members and their guests are expected to adhere to proper conduct, including, but not limited to: refraining from using abusive language; no harassment of team members or other Club guests; no violent behavior, such as club-throwing and interpersonal confrontations. Playing privileges may be suspended/or revoked.
- Limited Play members are eligible to play Monday – Thursday except on the following 2025 Stat Holiday Mondays: Monday February 17th, Monday April 21st, Monday May 19th, Monday August 4th, Monday September 1st, Monday October 13th.

ACCOUNT CHARGING APPLICATION

- Members are eligible to charge to their member account, which will be settled monthly by credit card.
- A valid credit card is required for all members who wish to charge to their account and/or those who make quarterly payments.
- Members who charge expenses to their account agree to have the provided card charged to settle outstanding balances.
- Failure to pay your account balance may result in suspension of charging privileges and/or playing privileges.
- Charges will be processed on the credit card provided on or near the 10th of the following month.
- Member event winnings are paid into a secondary account, known as the "Cash Equivalent" Account.
- An active member account in good standing is required to both receive winnings and access winnings for payments.
- Cash Equivalent winnings cannot be used towards monthly account charges or membership renewals.
- Olympic View Golf Club reserves the right to revoke charging privileges at any time.
- Accounts that are 45 days past due will incur 18% interest on the outstanding balance.

BOOKING POLICIES & PROCEDURES

It is Olympic View's goal to make the booking process as fair as possible for everyone, and we ask members to adhere to the following procedures. Members found in breach of our booking procedures will be subject to additional charges or penalties.

- If playing with other Olympic View members, designate 1 primary booker for your group that oversees the booking of your tee time(s).
- The primary booker is responsible for the accuracy of the booking and ensuring the number of players booked is the number of players that show up.
- If more than one tee time is required for your group, a second primary booker can be designated
- Fill in all information for additional players in the group. This allows accuracy and efficiency at check-in.
- One 10-day advance booking per 4 individuals is permitted. Members who are found booking multiple tee times on one day, selecting the best and then cancelling the rest, will be subject to a loss of booking privileges for 30 days and must call the golf shop to book
- Continued incidents will result in suspension or cancellation of membership.
- Bookings for singles, 2-somes, 3-somes and 4-somes are permitted. If you are a single player or 2-some, book yourself with another group. Olympic View reserves the right to pair up groups to ensure tee time optimization.
- Tee Time cancellations can be made directly through the online portal up to 48 hours in advance. Once inside 48 hours, you must call the golf shop directly to cancel or update a tee time.
- No Shows are the responsibility of the primary booker. Please ensure you are updating your bookings with accurate names of either Olympic View members or guests.
- Booked tee times and/or player spots that go unused will be charged a 'No Show Fee' to the primary bookers account at the member guest rate.
- All Members are expected to check in at the golf shop before heading to the first tee.

TO: *Gallagher's Canyon Golf & Country Club, Nicklaus North Golf Course, Okanagan Golf Club, Olympic View Golf Club and GolfBC Holdings Inc. and their respective directors, officers, shareholders, employees, instructors, guides, volunteers, agents, independent contractors, subcontractors, representatives, sponsors, successors and assigns (hereinafter collectively referred to as "the RELEASEES").*

DEFINITION

In this Release Agreement the term "Golfing" includes use of all Club facilities, including, without limitation, fairways, greens, driving range, restaurants, parking lots ("the Facilities") and rental and use of golf equipment and power carts ("the Equipment") and all other activities including involvement as a participant or spectator at group events, clinics, lessons, tournaments and competitions which take place at the Club.

ASSUMPTION OF RISKS

I am aware that Golfing involves many risks, dangers and hazards including, but not limited to slips and falls; being hit by stray golf balls or golf clubs; accidents or collisions involving motorized golf carts; lightning strikes; encounters with domestic or wild animals; failure to act safely or within one's own ability or to stay within designated areas; negligence of other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE.

I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS & HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT.

RENTAL EQUIPMENT AGREEMENT

- I accept full responsibility for the care of any power cart or rental clubs that I use (the "Equipment") and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned by the agreed date.
- I am familiar with the proper use of the Equipment. I understand that the rental staff is able to answer questions I may have as to the proper use of the Equipment.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees permitting my use of the Facilities or rental of the Equipment, I hereby agree as follows:

- TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and TO RELEASE THE RELEASEES from any and all liability for any damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use of or presence on the Facilities or my use of the Equipment, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF STATUTORY DUTY OF CARE, INCLUDING ANY DUTY OWED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c.337, in respect of the selection or maintenance of the Equipment or in respect of the provision or failure to provide any warnings, directions or instructions as to the use of the Equipment or the risks, dangers and hazards of Golfing. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE;
- TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to or loss of property of or personal injury to any third party;
- This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
- This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction; and
- Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.

GOLFERS' RESPONSIBILITY CODE

There are elements of risk that common sense and personal awareness can help reduce. Please adhere to the Code listed below and share with others the responsibility of a safe golf experience.

KNOW THE CODE – BE SAFETY CONSCIOUS, IT'S YOUR RESPONSIBILITY

- ① **IN ACCORDANCE WITH THE LIQUOR LICENCING LAWS OF BRITISH COLUMBIA - NO ALCOHOLIC BEVERAGES OTHER THAN THOSE PURCHASED AT THE GOLF COURSE SHALL BE PERMITTED ANYWHERE ON THE PREMISES.** Please drink responsibly at all times.
- ② **Please be aware of your surroundings. Do not hit the ball in the direction of other golf course users, objects on the golf course or dwellings in the vicinity of the golf course. You will be liable for any injury or damage.**
- ③ **Please observe and obey all golf course signage or GPS notifications (if applicable) at all times.**
- ④ **A valid driver's licence is required to operate a power cart. Please drive all power carts in a safe and responsible manner. Comply with cart directional signage at all times as this does change on a regular basis. Allow sufficient space when stopping behind or passing other golf course users. Maximum 2 people per cart.**
- ⑤ **Pace of play is a priority at this facility. For everyone's enjoyment, please adhere to our pace of play reminders.**
- ⑥ **Please do not drive carts on greens, tee boxes or into bunkers.**
- ⑦ **If you witness an accident or any kind of unruly or irresponsible behaviour please report it immediately to the nearest staff member and provide a complete account of the occurrence.**
- ⑧ **Please refrain from entering environmentally sensitive areas. These are marked with signage or green top red stakes.**
- ⑨ **Please remember the 3 R's – Repair your ball marks, Replace your divots and Rake the bunkers after use.**
- ⑩ **Respect your fellow golfers and have fun.**
